Following terms are replaced in our Form No. IPR-LP-PT-02.V1 for Tender no. IPR/TN/PUR/TPT/17-18/42 dated 28/2/2018

- 1) Sr.No.29 under heading “Delivery” of Form No.IPR-LP-PT-02.V1 (Terms and Conditions) is replaced with the following:

**Delivery including installation, testing & commissioning:** Tenderer should note that no tender will be considered by the Purchaser unless the Tenderer can meet the delivery schedule specified by the Purchaser. All equipments/machinery/plant/ component covered by this tender document should be supplied & commissioned within **8 months from the date of approval of execution drawing.** **Tenderer may refer clause No. 1.3 of Part-A (Technical Specification) for more details.** The prices quoted by the tenderer should include all charges involved for direct and safe delivery of the items by Road to the project site of the Purchaser. If a tenderer so desires/separate lumpsum charges for transportation and safe delivery to Purchaser’s site could be furnished. Purchaser will neither undertake responsibility for transit insurance nor pay for it separately. No other, delivery term will be accepted by the Purchaser

- 2) Sr. No. 37 under heading Mode of Payment of “General Conditions of Contract” of Form No.IPR-LP-PT-02.V1 (Terms and Conditions) is replaced with the following:

**Payment:** Unless otherwise agreed to in writing between the Purchaser and the Contractor, payment for the delivery of the tendered items, will be made as follows.

- a) 80% of basic price (supply part of SOQ) + 100% of all other charges of basic price will be paid against delivery of material at IPR site, its verification by IPR representative and on receipt of proforma invoice in triplicate on pro-rata basis (i.e. 80% of each item shall be made against delivery of that item); provided all working drawings have been submitted by the contractor. **Note: Pro-rata payment shall be made upto maximum 3 (three) bills.**
- b) Balance 20% (supply part of SOQ) and 100% of installation charges mentioned in SOQ will be paid within 30 days after successful testing and commissioning of Water Distribution System; taking over the System by IPR; submission of documents by the contractor as listed in the tender; and also on submission of Performance Bank Guarantee for 10% of the order value from

SBI/nationalized banks or any one of the scheduled banks mentioned in the bracket (Axis Bank, HDFC Bank, ICICI Bank and IDBI Bank) valid throughout the warranty period and on receipt of final invoice. The Bank Guarantee submitted should cover all liabilities mentioned in the General Terms & Conditions.
