

#### 1. SCOPE OF THE WORK

- a) To publish advertisement /Tender Notice, etc. in English/Hindi and regional languages of all nature in the local newspapers, national newspaper or at international level.
- b) To follow instructions of the Institute in respect of the newspapers chosen as well as publication.
- c) To do all related work like spell/grammar checking, composing economic flawless layout etc. for the advertisement release and to adhere with the timeline of release.

#### 2. **SERVICES**

- a) Timely release of advertisement of all nature in the local newspapers, national newspapers or at international level at **DAVP rates**.
- b) To ensure preparation of economic flawless layout.
- c) To publish advertisement in the local and national newspapers or as directed by the Institute within stipulated time and clipping should be sent to us immediately.
- d) To collect advertisement matter from the Institute.
- e) To get the layout and proof approved from the Institute
- f) Any other job related to advertising agency.

#### 3. STIPULATED TIME

#### 4. CHARGE

- b) Goods and Service Tax applicable from time to time may be charged as per Govt. of India rules.
- c) No production cost, collection & delivery charges, service charges and courier shall be levied.
- d) You will not be entitled for any charge other than specified hereinabove.
- e) <u>PAYMENT</u> The successful agency/s has to submit a monthly bill(s) on or before the 5<sup>th</sup> day of the subsequent month. The payment will be released within 30 days of receipt of the bill & its scrutiny.

#### 5. ARBITRATION

Any dispute, difference or objection with regards to any matter relating to this contract shall be referred to the sole Arbitration of any person appointed by the Director, IPR at the time of reference. The decision of the Arbitrator so appointed, shall be final and binding on both the parties.

#### 6. TERMS & CONDITIONS

## BIDDER IS ADVISED TO MAKE THE OFFER AFTER CAREFULLY READING AND UNDERSTANDING THE FOLLOWING TERMS & CONDITIONS :-

- 1. The Agency shall be required to provide excellent & quick services for advertisement release.
- 2. Only the rates fixed by Directorate of Audio Visual Publication (DAVP) will be applicable for national and local newspapers.
- 3. Submit a copy of Goods and Services Tax Registration documents along with your offer.
- 4. The advertisement may be required to be released at local, national or international level.
- 5. The agency will be required to make an economical layout of the matter and get it approved from the Institute before release.
- 6. The contract will be awarded for a period of two years with an initial trial period of three months. Trial period would be extended if found necessary by the Institute at its sole discretion.
- 7. IPR reserves the right to terminate the contract if the services are not found satisfactory, by giving one months' notice and if the Agency wants to terminate the contract they will be required to give three months' notice in writing giving reasons thereof.
- 8. The Agency should sign all the pages of the tender documents before submission, as a token of having read & accepted the terms and conditions.
- 9. In case of any dispute on any matter, the decision of the Director IPR will be final and binding.

- 10. IPR reserves the right to choose one or more parties or cancel the tender in to at its sole discretion.
- 11. Agencies who wish to attend the tender opening should invariably carry an authorization letter from their company, failing which they will not be allowed to participate in the tender opening process. However a single participation is only allowed from each company.
- 12. The agency shall maintain a register for the advertisements released by the Institute and rotation of the newspaper as per the requirement of the Institute.
- 13. The agency shall provide the services of the English to Hindi /Gujarati translation or vice versa for the release of advertisement in different languages.
- 14. The agency shall arrange to send the draft advertisement along with estimate for the approval of the institute.
- 15. In case of lack in promptness, efficiency, feedback, wrong release or mistake in the advertisement draft by the agency, non-timely release of advertisement or any such lapse in services creating inconvenience to the Institute, the institute may impose a penalty ranging from ₹ 500/- to ₹ 5000/-. (to be decided by the Competent authority of IPR depending on the gravity of the lapse/s) If needed the same advertisement or corrigendum may be asked again to be released against at the cost of the advertising agency.

<u>Security Deposit</u> - The Successful bidder/bidders shall within three weeks from the date of issuance of Work Order, shall submit an irrevocable Bank Guarantee (BG) equal of Rs. 2,50,000/- (Rupees Two Lacs Fifty Thousand only) on a non-judicial stamp paper, as "Security Deposit" towards satisfactory execution and performance of the Contract. <u>Security Deposit will be divided proportionately amongst the parties / agencies selected.</u>

For the BG towards the security deposit is issued by an Indian bank, it shall be from State Bank of India (SBI) /from any other Nationalized Bank /from one of the banks namely ICICI, HDFC, AXIS and IDBI.

The Bank Guarantee shall remain valid till the expiry of (60) sixty days from the completion of the event under this Contract. If need arises, the Contractor shall extend the validity of the Bank Guarantee for suitable period at his expenses.

If the Contractor fails to provide the Security Deposit (SD), within the period such failure shall constitute a breach of Contract and the Institute shall be entitled to cancel the Contract and make alternate arrangements for the event from other sources at the risk and expenses of the Contractor and recover from the Contractor the damages arising from such cancellation.

In the event, the Courier agency fails to fulfill any of the obligations under the Contract; Institute for Plasma Research shall have the right to encash the Security Deposit.

Upon satisfactory completion of the Contract, the original Bank Guarantee (s) shall be returned to the Courier Agency after three months from the date of completion of the contract, on receipt of a request from the Agency.
